Now that we are entering Spring, we need to remind everyone that school begins at 7:20 am. Students need to be in the building no later than 7:15 in order to make it to their first period class on time. If students are late due to stopping at one of our neighboring restaurants, they will not be allowed to take the food or drink into class. Breakfast is available each day in our cafeteria beginning at 6:50 each morning.

Additionally, please remind your student that everyone who enters our campus must have on their ID. This is a safety measure that is consistently monitored throughout the day. Also remember our [academic dress code](#) is in place to keep everyone focused on LEARNING.

Our campus received many renovations to assist us with keeping everyone safe. One important measure is our secure vestibule. All visitors must be "buzzed in" in order to enter. Once a visitor enters they must show a valid, government ID in order to access our building. Additionally, in accordance with campus safety procedures, only the listed parent or guardian will have access to students and student information. If a parent would like someone other than the guardian to pick up a student, a note from the parent must be received in the morning. The note will be verified by a staff member by phone, prior to release of the student. Thank you for your cooperation in these important safety measures.

Morning safety continues to be a focus for improvement. The front doors are opened at 6:50 am. Because of safety, students are not allowed in the building without adult supervision. Additionally, the front parking lots are designed for registered staff and student parking. These are not drop off areas for
